Exhibitors may enter facility to set-up from 9am on April 9, 2010 until 7pm that day according to the time printed on their registration pass which will be issued upon payment of Fees.

*Exhibitors Must use the designated load in areas and MUST Move their vehicles IMMEDIATELY after unloading. You cannot leave your vehicle inside the building while you set up your booth.*

### Liability & Indemnification:

*Reasonable precautions will be taken by The Spartanburg EXPO to protect persons and property during the UPSTATE'S LARGEST INDOOR YARD SALE, however, neither The Spartanburg EXPO, it's agents, assigns nor representatives shall be responsible for the personal safety of the Exhibitor, it's representatives or the Exhibitor's personal property. Exhibitors agree to hold*

*Spartanburg EXPO, it's agents and assigns; harmless from all claims, including expenses, damages, costs, and attorney's fees for any person arising out of any act of omission related to the Exhibitor's participation in the Upstate's Largest Indoor Yard Sale.*

**PAYMENT TERMS:**

*Exhibitor shall NOT be permitted to bring any equipment, goods, or display any material into the EXPO Exhibit Hall without prior FULL PAYMENT, Booth Registration Pass and signed Load-In Pass. All Payments are Non-Refundable and Non-Transferable and space Reservations may not be canceled. Credit Card Payments shall be accepted and receipt can be picked up on Move In Date. There shall be a \$50 Returned Check fee applied for all vendors.*

**LIABILITY FOR DISTRIBUTION OF EDIBLE ITEMS:**

*Distribution or Sale of samples of food, cake or other edible items Is subject to approval by The Spartanburg EXPO Management and Is to be governed by the rules and restrictions set forth by the State of South Carolina, County of Spartanburg and must be*

*prepared in a licensed food preparation location. Written Approval of said food items must be made by The Spartanburg EXPO Management PRIOR to April 9, 2010. Violators of this policy will be escorted out of the Yard Sale by a Licensed Police Officer and No Refunds are to be issued.*
